ELIGIBILITY TO VOTE

For the purposes of the National AGM, a person is entitled to vote if the person is a Member of NELA and the Member's membership rights are not suspended for any reason.

If you have not yet paid your membership fees for the 2024-2025 financial year, you must do so by **5:00pm AEDT Tuesday 5 November 2024**. If you do not pay your membership fees for the 2024-2025 financial year by this time, you will NOT be eligible to vote at the National AGM.

PROXY FORM

Members may appoint another Member to attend, speak and vote at the National AGM, as the Member's proxy, by completing the Proxy Form at Annexure B and submitting it to NELA in accordance with the requirements specified on the Proxy Form itself and on the Notice of National AGM. A member who is entitled to cast 2 or more votes may appoint 2 proxies and may specify the proportion or number of votes each proxy is appointed to exercise.
