10:00am AWST (Perth) (for a 10:15am start)

Important: from 1:00pm – 1:15pm AEDT, registration and credentialling of Members will take place. **You must log on online during this time to be properly registered and credentialled before the National AGM commences at 1:15pm AEDT.**

PROXY FORM

Members may appoint another Member to attend, speak and vote at the National AGM, as the Member's proxy, by completing the Proxy Form and submitting it to the Association in accordance with the requirements specified on the Proxy Form itself and on the Notice of National AGM. A member who is entitled to cast 2 or more votes may appoint 2 proxies and may specify the proportion or number of votes each proxy is appointed to exercise.

Any Proxy Form that is not received in accordance with the above timeframes will not be valid for the National AGM.

Non-members are welcome to attend the National AGM but will not be eligible to vote on the items of business (see further details below on eligibility to vote).

ELIGIBILITY TO VOTE

For the purposes of the National AGM, a person is entitled to vote if the person is a Member of the Association and the Member's membership rights are not suspended for any reason.

If you have not yet paid your membership fees for the 2022-2023 financial year, you must do so by **11:59pm AWST 28 November 2022**. If you do not pay your membership fees for the 2022-2023 financial year by this time, you will NOT be eligible to vote at the National AGM.

ELECTIONS

If more than 13 nominations are received for the positions of NELA Board Director, elections for the will be held at the National AGM.
